A. **DESIGN REVIEW REQUEST TO MODIFY THE EXTERIOR OF THE STOREFRONT AT 890 SOUTHAMPTON ROAD IN THE SOUTHAMPTON SHOPPING CENTER (RALEY'S), AFTER A DETERMINATION THAT THE PROJECT IS EXEMPT FROM CEQA**

PROPOSAL:

The applicant requests design review approval to modify the commercial building (Raley's) in order to remodel the front (east) and side (north) facades and to repaint the rear (west) and side (south) facades to complement the overall design. The proposed work includes modifications to the architectural style, materials, landscaping, pedestrian circulation, and height of the storefront, and addition of a canopy on the north façade for customer grocery pick-up.

Recommendation: Approve the design review request to modify the front and side facades of the existing Raley's commercial storefront at 890 Southampton Road; after a determination that the project is categorically exempt from CEQA.

B. **WORKSHOP – NORTHGATE CHRISTIAN FELLOWSHIP PHASE 2 DESIGN**

PROPOSAL: On June 30, 2014, Northgate Christian Fellowship church submitted for Use Permit and Design Review approval to modify the site plan, phasing and building design as well as to add additional modular facilities and outdoor storage facilities to the site. The project was originally approved in 2003 (revised in 2004) and was divided into 3 phases. Currently 1 phase has been constructed. The purpose of this workshop is to provide feedback and input to the applicant on the design of Phase 2 which is the primary assembly (sanctuary) building. Following the workshop, staff will work with the applicant to finalize plans and schedule this matter for a Design Review hearing.

Recommendation: Review the proposed project and provide feedback to the applicant regarding building design for the proposed Northgate Christian Fellowship sanctuary building.

Pursuant to Government Code Section 65009; if you challenge a decision of the Historic Preservation Review Commission in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this notice, or in written correspondence delivered to the Historic Preservation Review Commission at, or prior to, the Public Hearing. You may also be limited by the ninety (90) day statute of limitations in which to file and serve a petition for administrative writ of mandate challenging any final City decisions regarding planning or zoning.

Appeals of Historic Preservation Review Commission decisions that are final actions, not recommendations, are considered by the Planning Commission. Appeals must be filed in the Community Development Department in writing, stating the basis of appeal with the appeal fee within 10 business days of the date of action.
