

CERTIFICATE OF INSURANCE AND ENDORSEMENT

Attached are examples of the Certificate of Insurance and Endorsement required by the City of Benicia.

The City of Benicia asks that an Endorsement be included for the General Liability policy (and Auto as required) adding the City of Benicia as additional insured. It is insufficient to merely add the City in the description section of the Certificate of Liability Insurance. Instead, we ask that the endorsement be on a separate page.

→ **The Certificate of Insurance should name as the Certificate Holder:**

If you will have alcohol present at your event, you **MUST** include Host Liquor Liability in your policy.

→ **The separate Additional Insured endorsement page, should name the following as additional insured:**

The City of Benicia, its Council Members, Officers, Agents and Employees

Benicia, CA 94510

A blanket endorsement will not be accepted.

Please do not send your insurance/endorsement directly to the City Attorney's office. It must be sent to the department so that the proper contract can be attached to the insurance. We will forward the documents to the CAO for you. You may also purchase insurance directly through us, if that is more convenient.

1. In the performance of your ongoing operations; or
2. In connection with your premises owned by or rented to you.

However:

1. The insurance afforded to such additional insured only applies to the extent permitted by law; and
2. If coverage provided to the additional insured is required by a contract or agreement, the insurance afforded to such additional insured will not be broader than that which you are required by the contract or agreement to provide for such additional insured.

B. With respect to the insurance afforded to these additional insureds, the following is added to **Section III – Limits Of Insurance:**

If coverage provided to the additional insured is required by a contract or agreement, the most we will pay on behalf of the additional insured is the amount of insurance:

1. Required by the contract or agreement; or
2. Available under the applicable Limits of Insurance shown in the Declarations;

whichever is less.

This endorsement shall not increase the applicable Limits of Insurance shown in the Declarations.
