

Jumper/Inflatables and Rental Equipment Policies for Benicia Parks

1. RENTERS MUST HAVE A JUMPER PERMIT ISSUED BY CITY, IN ORDER TO HAVE A JUMPER AT A PARK
2. Jumpers are permitted in the parks during park hours (8am – dusk).
- _____ 3. It is the renter’s responsibility to make sure that we have a copy of the contract at our office no less than 5 business days before the rental. Jumper contracts received less than 5 business days prior to the event may not be approved. No equipment is allowed in parks without a copy of the contract for the equipment on file at the Parks and Community Services office.
4. We only allow Jumpers in Benicia Community Park (maximum of 2), City Park (maximum of 1), and Jack London Park (maximum of 1). Jumpers are not permitted in any other City Park or open space.
- _____ 5. Jumpers may not exceed a set up footprint of 20’x20’x20’ in any of the parks.
6. The renter of the jumper must have a picnic site reserved to have a jumper in any of the aforementioned parks.
7. Jumpers are only permitted in designated areas directly adjoining the picnic sites. (Special Event permits are required for jumper to be placed in any other location).
- _____ 8. Other games, inflatables, food equipment, and carnival accessories, as well as additional tables and chairs are not permitted in the parks.
- _____ 9. Unapproved jumpers or other games/inflatables/accessories will be shut down.
- _____ 10. Park renters are not permitted to bring generators into the parks, so the generator must be provided by the jumper company. Electrical cords may not be trip hazards and cannot extend across a picnic site to power other items. **ONLY ONE GENERATOR PERMITTED PER PICNIC SITE:** The generator may only be used for the sole purpose of powering the inflatable.
- _____ 11. No vehicle access is available for park users to access picnic spaces. All supplies must be carried/carted in, and picnic attendees must use pedestrian walk ways to access picnic spaces.
12. Vendor vehicle access to the park to drop off/pick up the jumper is only permitted at Benicia Community Park. Access is only available when a Park Attendant is on the schedule (see dates/times below). Vehicle access to the picnic areas at BCP is **ONLY** available from 9am-10am and 2:30pm-3:30pm, and must be prearranged with Wendy Stratton Monahan to ensure that staff is at the park to allow access during these times. Access is via Kearney Street gate at BCP, which remains locked at all times.
13. Vendor vehicle access is **NOT GUARANTEED**, so vendors should be prepared to cart the jumper into/out of the park.
14. Park Attendant staff is usually scheduled on weekends between Memorial Day and Labor Day, and only when the picnic site reservations are at least 75% full. Staff is typically scheduled between 9am – 3:30pm
15. ALL jumper companies must have **CURRENT** insurance on file with the City to be able to contract with a park renter.
- _____ 16. There is no electrical or water access in the park. We do not permit any water activities in the parks.
- _____ 17. Amplified music/artificial noise is not permitted in the parks without a proper permit. This policy would relate to any games or inflatables that may have a noise component.

Please ensure that you are familiar with park rules in addition to the jumper policies.
