

The City's Liability Insurance Program, as well as Hull Insurance on the Police Boat, is due for renewal on the dates noted above. On renewal we hope to refine and expand the program and consolidate as much as possible with the Property Insurance Program with a single major insurer.

In order to achieve the best results in today's demanding underwriting climate, a maximum of detailed information as to the City's interests and activities is required, so we submit to you the enclosed application as well as a separate list of items on which we will need your comments and assistance in obtaining data.

We are still looking forward to receiving the completed Public Official Liability application which we sent on November 27th so that we may obtain a fresh quotation for this coverage.

In addition, we wish to confirm that the City's new Pool Cover has been received and installed as was anticipated for January 15th. We have tentatively bound coverage as of that date, subject to the same terms and conditions as apply to the City's other scheduled equipment.
